Set-Up The Cascade Pavilion will be available to Obedience & Rally exhibitors Cascade Livestock Pavilion for set up on Thursday between noon and 8 pm; 6:00 am Friday, Saturday & Sunday Crates etc. may be left overnight but must be removed before 8 pm Sunday.

IMPORTANT ENTRANCE/EXIT INFORMATION

The only entrance at the Linn County Fairgrounds will be the main entrance from Knox Butte Rd. The south entrance will be blocked off.

The only exit will be the one adjacent to the Main entrance ticket booth. The other 2 exits on the east side of day parking will be blocked off.

RV entrance is unaffected.

This was necessary due to fairgrounds south ticket booth damage making it unusable.

Day Parking east side of the Fairgrounds. Day parking is \$5 each day per space per vehicle. Oversized vehicles will be charged for 2 spaces if greater than standard length or width. There is NO overnight parking in the day lot. No exercise pens, set-ups or grooming in the day lot. Vehicles illegally parked may be towed without notice at owners expense. Parking will be monitored by Linn County Sheriff.

Unloading You may unload outside the Willamette Events Center/Santiam Building adjacent to day parking OR drive to rear of the Livestock Pavilion via the RV/Vendor gate. You must leave this area within 15 minutes; leave emergency flashers on. You may NOT leave your vehicle in this area after unloading. DO NOT move barriers and follow all signs and parking attendants. Crates and chairs may be left overnight but must be removed no later than 8 pm Sunday.
