Photocopied entries without the AKC agreement on the back or attached are NOT acceptable. **Returned checks or declined credit card transactions** do not constitute a valid entry fee.

Changes, Additions or Corrections to entry forms must be received in writing or by email prior to the close of entries. Telephone changes, additions, corrections received by telephone are not acceptable.

Additional Rules & Information

Returned Checks/Declined Transactions The Event Secretary will add a \$25 service charge for each returned check or declined credit card transaction. Subsequent invalid payments from the same exhibitor may result in being placed on a CASH ONLY basis.

Refunds Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by the action of the Event Committee. No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Bitches in season are not permitted to compete in Obedience or Rally events. If a bitch is withdrawn from such competition because she came into season and trial secretary is notified in writing at least one-half hour prior to the start of the event, the club will refund entries withdrawn under this section. See AKC Obedience Regulations Chapter 1, Section 14 and Rally Regulations Chapter 1 section 13.

Move-ups and Transfers will be accepted for these events but must be received by the trial secretary no later than Wednesday April 5, 2023 if mailed. After that time, hand delivered move-ups or transfers will be accepted until 30 minutes prior to the start of judging each day.

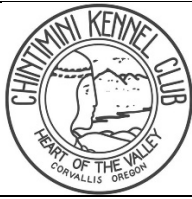

parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
